Fees

- 1997/8 Fees
 - £45K large sponsor proposed in Autumn 96
 - but on false expectation of recruiting more sponsors
- Secondees at sponsor's own cost (cf FJL)
- No capital budget use APM Ltd equipment
- No bundled consultancy, but access to ANSA team as per contracts (nominal 5 days)
- APM Ltd will continue to offer discount rates on consulting and training to sponsors as an additional benefit



Budget

- 8 Sponsors @ £45K/yr = £360K/yr
- Labour rate = £65/hr * 137hrs = £8905/mm
- Therefore ANSA = 3.37my/y

n.b. Fujitsu pays additional £45K to cover secondee provision and annual trip to Japan

But APM gets income from associated ESPRIT & DTI Projects which can be ploughed back in



So, for 1997/8

- Sponsors pay £45K each
- APM earns approximately £210K by linking to ESPRIT projects
- Produces team of 5
 - with PD/CA, support and equipment wrapped
 - into overheaded rate
- Constraint
 - FlexiNet and Puppies are the content of the work programme
