Minutes of the AGM held 17th October 2019 at 2pm at BCS

Meeting was chaired by David Morriss and attended by 25 members. Apologies had been offered by a number of members.

- 1. Minutes of 2018 AGM had been circulated and were approved.
- 2. Chair's Report This had been published in Resurrection and circulated in the room. The report was accepted.
- 3. Treasurer's Report The Treasurer reported that the budget from the BCS had been largely spent. The 2019/20 was a little less but should be adequate. The Restoration Fund had received £3,500 from members together with a one-off gift if £500 and a grant had been made for information boards for EDSAC of £3,000. The Tony Sale Award for 2018 had exhausted the original Google grant. A new sponsor is being sought.
 - The Chair thanked the Treasurer for all his work sorting out the accounts.
- 4. CCS Officers, CCS Project Leaders, CCS Associate Representatives The Chair explained that due to unforeseen circumstances Doron Swade had asked to defer taking over as Chair for 12 months. The Committee had asked the present incumbent to continue for a further year, which he had agreed.

I hope to continue to serve the organisation going forward and wish Doron Swade every success as he takes over the office of Chairman.

Treasurer's AGM Report - October 2020

1. Operational Budget

The overall costs of events and meetings in this year were well within the allocated budget (itself being less than we had requested). However, within those totals the speakers' expenses did exceed their planned budget significantly, but other items came in well under budget to compensate. If the programme had not been prematurely terminated by the pandemic, the outcome would certainly have been much closer.

Again, the costs of printing and distributing *Resurrection* continued to be paid from a central budget outside of CCS's, and no room hire costs were incurred.

The budget awarded for the new financial year had been significantly reduced to reflect the planned lack of physical meetings, but should be adequate for predicted expenditure under the current situation.

2. Donations and Grants

Total donations received were £4,960*, this year entirely from private members, reversing the downward trend of recent years.

Two grants were made this year:

- £80 for Raspberry Pi hardware to support the KDF9 & EDSAC Emulations Server Project at TNMoC;
- £1000 as a contribution towards a display plinth for the HEC at TNMoC.
